Proposed Amendments to the Constitution and By-Laws

To be voted upon at the Annual Meeting in Detroit, Mich., June 23rd and 24th, 1930

Amendments to the Constitution:

ARTICLE III—MEMBERSHIP.

Section 1. In line 2, change "three" to "four" and add after "(c) honorary" the words, "(d) Fellow." In line 12, after "Directors" add "A Fellowship will be issued only by authority of the Board of Directors to an active member of the Association who has been a member for five years, or who has made some definite contribution towards the advancement of Industrial Medicine and Surgery, or performed some special service for the Association." Delete the balance of line 12 and all of lines 13, 14 and 15.

Section 3. Delete balance of line 10 after the word "President," and all of lines 11 and 12.

Add:

"Section 4. The names of those who are eligible for Fellowship by length of membership in the Association shall be presented by the Secretary to the Board of Directors for their approval at the time of the Annual Meeting. The names of others who may be deemed eligible for Fellowship may be presented, through the Secretary, to the Board of Directors by any member or Fellow of the Association."

"Section 5. A two-thirds vote of all directors present at any session of the Board of Directors shall be required to elect to any class of membership."

"Section 6. A certificate of membership in the class to which he belongs will be issued to each member upon his election."

ARTICLE IV—OFFICERS.

Section 1. In line 3 after "They shall be" insert "Fellows of the Association and shall be."

Section 2. In line 3 after "directors" insert "Only active members and Fellows shall be eligible to serve on the Board of Directors."

Amendment to the By-Laws:

ARTICLE II—DUES.

Section 1. In line 2 after "per year" insert "and of Fellows shall be Ten Dollars per year."
